Since our last newsletter, the IDCA was invited to join the Health Quality Ontario (HQO) Expert Panel on Peer Review Systems in Diagnostic Imaging. The expert panel will use your responses to gain a better understanding of what quality systems are already in place. Their goal is to create one peer review system for all radiologists. As you are aware, the Ministry and the OMA are currently engaged in the negotiation of a new Physician Services Agreement. ## Quality in Diagnostic Imaging

Thank you to our members who completed the Health Quality Ontario (HQO) survey for IHF facilities regarding current quality systems in place within your operations. Your responses have provided critical information to the expert panel and will assist in future recommendations to the Minister of Health.

As part of the development process, Health Quality Ontario has engaged the assistance of Price Waterhouse Coopers' Health Industries Practice team to assist with a jurisdictional scan and literature review of quality and peer review programs both in Canada and the United States.

Although the review to date has shown no established leading program(s) for peer review, the data collected helps us to better understand the various components the panel needs to contemplate. While still evolving, the program goals for an Ontario Quality model include:

- Improving the consistency and accuracy of radiology services to improve quality for patients,
- Supporting improved diagnostic

image interpretation skills through peer-to-peer learning, and

• Enabling informed decisions about patient treatment, enhancement of quality programming, physician training and continuing medical education.

## A message from X-Ray Inspection Services (XRIS)

Based on the feedback received from our clients and stakeholders since the initial distribution of the XRIS information pamphlet in July 2013, we have since enhanced the information pamphlets to reflect the current installation plan approval process. The revised pamphlets help to provide guidance for respective types of X-ray facilities in achieving legislative compliance. The pamphlets are divided into the following areas:

- General information for owners & operators of X-ray facilities
- Approval of an installation plan for radiation shielding for medical X-ray facilities.

The pamphlets also provide supplementary information on the revised Forms 1, 2, and 3, which were distributed in February 2014.

As a friendly reminder, as of April 1, 2014, Forms 1, 2, and 3, became mandatory for all installation plan applications and X-ray equipment registrations.

## By July 1st - Mandatory Health & Safety Training

To help prevent workplace incidents and injuries, workers and supervisors are being made more aware of their roles, rights and responsibilities through new workplace training.

As of July 1st, 2014, new Health & Safety Training is mandatory for all workers and supervisors in Ontario who are covered by the Occupational Health and Safety Act.

Workers and supervisors may either take part in a one-hour tutorial free online, either individually or in groups, or review hardcopy workbooks.

Once the e-learning training module is complete, an employee will receive a certificate that is valid for the remainder of his or her career.
